



Commercial heat pump water heater rebate

Customer requirements

- You must be a current PSE commercial and/or industrial electric customer.
- PSE gas-only customers are not eligible for the rebate.
- Residential, multi-family, and new construction customers are not eligible for the rebate.

Equipment requirements

- You must purchase a model found on PSE's certified [Qualified Products List](#) (QPL), consisting of ENERGY STAR® certified products. The heat pump water heater must meet Tier 3 or greater specifications, and must be equipped with a CTA-2045 compliant communications port (EcoPort) to meet Washington State Plumbing Code 501.1.2.
- Unducted units must be installed within an unconditioned space, such as a garage or unconditioned basement or storage room.
- Ducted units must have exhaust air ducted to the outside.
- Split-Systems must meet [PSE Rebate Requirements](#).
- Rebates only available on new, qualifying equipment.
- Your heat pump water heater must run on electricity.
- You must be replacing an existing electric resistance water heater.

Rebate requirements

- Must install to comply with all federal, state and local code requirements.
- Your rebate application must be submitted within 60 days of equipment purchase.
- This rebate is available for purchases made from installation contractors, distributors, retail stores, and online merchants.
- Each heat pump water heater unit is only eligible for one PSE rebate
- Heat pump water heater units must be purchased after January 1st, 2024. Units purchased prior to January 1st, 2024 are eligible for the rebate only if the installation contractor provides the distributor invoice directly to PSE to verify that they did not already receive a rebate, or provides the distributor information for where the unit was purchased for PSE to follow up on internally.
- Rebate cannot exceed the pre-tax, pre-installation purchase price of equipment.
- Products that are replaced under warranty will not be eligible for second rebate.
