



Center City Connector Streetcar public improvements project

Improving your natural gas service

In conjunction with Seattle Department of Transportation's (SDOT) Center City Connector Streetcar project, Puget Sound Energy is working to relocate, reconfigure, and protect segments of natural gas pipeline in downtown Seattle to ensure continued public safety and customer reliability.

This work will be coordinated with other utility relocation work in advance of Center City Connector Streetcar construction. PSE is working closely and proactively with SDOT and other jurisdictions and agencies to ensure the continued safety and reliability of our existing natural gas system in the area.

A portion of the project was completed in 2017. See map on next page to view the completed sections.

Here's what to expect:

What: Work entails relocation of intermediate pressure (IP) natural gas line and replacement and relocation of two service regulators, which convert the pressure of the system's natural gas so it can be used by customers.

Where: Continuing along 1st Ave S, from S Main St to Madison St. Please see map for details.

Who: Crews from PSE and our approved contractors.

When: February through April 2018,
Sunday through Friday
7 p.m. - 5 a.m. and 9 a.m. - 3 p.m.
(16 hour days)

*Some additional weekend work during the day may be necessary. Surface cuts, excavation and other high impact construction activities will be scheduled during the evening shift.

This work schedule will shorten the active construction window by up to 8 weeks.

Note: Additional sections of IP natural gas pipeline along 1st Ave between Stewart St and Seneca St will be relocated as part of this project. Detailed information will be shared with impacted customers as this construction stage becomes active.

Construction

We will work diligently to minimize impacts to neighbors, the environment, and traffic during construction.

- There may be some temporary impacts to traffic conditions during construction. These include localized lane closures and limited access to on-street parking. Flaggers will be on site at all times to ensure vehicles and pedestrians are safely directed through work zones.
- Night work is required for this next stage of construction activities. We will adhere to all applicable city requirements regarding acceptable noise levels at night.
- Some work may require a temporary disruption in service to natural gas customers. If a natural gas outage is necessary, a PSE representative will coordinate directly with affected customers.

2018 work includes:

- Relocation of IP natural gas line along 1st Ave S, from S Main St to Madison St.

- Replacement and relocation of two service regulators along 1st Ave S, between Columbia St and S Main St.

Safety

Safety is our top priority when it comes to designing, constructing, operating and maintaining a natural gas system that serves more than 800,000 PSE customers. We are committed to listening to our customers, maintaining an informed and open conversation about our work, and being responsive to customer needs.
