Dear Mr. Johnson:

Attached please find the updated Work Plan Schedule for Puget Sound Energy's ("PSE's") 2019 Integrated Resource Plan ("IRP"). It is filed pursuant to the IRP rules under WAC 480-90-238(4), (5) and WAC 480-100-238(4), (5) and Order 01 dated February 15, 2019 in the above-referenced dockets. Updates are provided for Appendix A (Work Plan Schedule Update).

The filing date for the 2019 IRP has been revised to January 15, 2020. This extension ensures that PSE incorporates the outcome of new clean energy legislation into PSE's long-term resource plan. To date, PSE has held five Technical Advisory Group (TAG) meetings and two Integrated Resource Advisory Group (IRPAG) meetings to solicit public input for the 2019 IRP. It is clear to PSE from these meetings that stakeholders are interested in clean energy legislation. PSE looks forward to re-engaging with the public following the conclusion of the legislative session. To more fully address stakeholder interest, two additional TAG meetings have been added to the Work Plan Schedule Update.

The Work Plan Schedule has been developed with some input from stakeholders. Given the filing deadline, another update to Appendix A is anticipated to formalize the meeting location and potentially change some of the meeting dates to ensure maximum public input.

This updated Work Plan Schedule supersedes any previous work plan schedules filed in these dockets.
