

CONTRACT FOR CONSTRUCTION (NO. _____)

This Contract, dated as of _____, 2003, is made by and between **Puget Sound Energy, Inc.** ("Owner") and _____ ("Contractor"). Owner and Contractor agree as follows:

1. **DESCRIPTION OF WORK.** Contractor shall perform for Owner the following work: _____ (the "Project"): Provide all resources required to complete the Work in accordance with the contract documents and any addenda thereto.

2. **COMPENSATION.** As full compensation for satisfactory performance of the Work, Owner shall pay Contractor compensation in accordance with the prices set forth in the attached _____, and the payment provisions of this Contract.

3. **SCHEDULE FOR PERFORMANCE.** Contractor shall not commence performance of any of the work until Contractor's receipt of written notice to proceed from Owner ("Notice to Proceed"). Upon receipt of Notice to Proceed, Contractor shall promptly commence and diligently prosecute performance of the Work so as to complete the Work in accordance with the Construction Schedule approved by Owner pursuant to GC-9, entitled "Construction Schedule; Progress Reports", of the General Conditions and any other schedules attached to, incorporated into or otherwise made a part of this Contract. Time is of the essence in the performance of Work.

4. **PLACE OF PERFORMANCE.** Contractor shall perform the Work at _____ County, Washington.

5. **PERFORMANCE OF WORK.** Contractor shall perform the Work in accordance with, and shall comply with, all of the provisions of this Contract which include the provisions set forth in this Contract for Construction, the attached General Conditions, Special Conditions, Technical Specifications, Drawings and Schedule of Bid Prices, and all other specifications, drawings and other provisions and documents attached to, incorporated into or otherwise made a part of this Contract (collectively, the "Contract").

6. **PROMOTIONAL AND ADVERTISING RIGHTS.** Except as may be required by law, neither party to this Contract shall, without the prior written consent of the other, make any news release or public announcement or place any advertisement stating that PSE and Contractor have contracted for the products or services specified in this Contract or have entered into any business relationship. Use of any PSE name, trademark or service mark in any promotional materials of Contractor requires PSE's prior written approval, which is subject to the sole discretion of PSE to grant or withhold. In the event that PSE approves the use of its name, trademark, or service mark in any announcement, news release or promotional materials of Contractor, all of the contents shall be submitted to PSE's Corporate Communications Department for review prior to any publication by Contractor.
