**SCHEDULE 136
LARGE VOLUME GREEN ENERGY
PURCHASE RIDER**

AVAILABILITY:

1. Service under this schedule is available to any Customer who wishes to purchase 1,000,000 or more kWh per year of green energy; and
2. Service is available to Customers entering into a service agreement under this schedule for a minimum term of one year. After such term service is available on continuing month to month basis. (N)

3. For the purposes of this schedule only, Customers may aggregate loads at multiple locations served by the Company in order to meet the 1,000,000 kWh minimum purchase of green energy.
4. Service under this schedule is available to Customers as an option designed to provide Customers an opportunity to purchase qualified alternative energy resources.
5. Participating Customers will support the use and development of alternative energy resources or "green energy" resources which are generation facilities fueled by energy sources which include wind; solar energy; geothermal energy; landfill gas; wave or tidal action; gas produced during the treatment of wastewater; qualified hydropower; or biomass energy based on animal waste or solid organic fuels from wood, forest, or field residues or dedicated energy crops that do not include wood pieces that have been treated with chemical preservatives such as creosote, pentachlorophenol, or copper-chrome-arsenic. TYPE OF SERVICE:

Service under this schedule is provided through Renewable Energy Credits ("Credits") obtained by the Company. These Credits will be provided through either: (a) Resources the Company owns or contracts for; or (b) the purchase of Credits issued by a clearinghouse or other system, provided the Company is able to secure verifiable evidence that there is a qualified alternative energy resource available and that the green energy attribute of the alternative energy resource will be available to the Company for purchase by its Customers.

MONTHLY RATE:

Customers may purchase an unlimited number of kWh of green energy at \$0.006 per kWh, with a minimum monthly purchase of 83,334 kWh of green energy per month. Under this option the monthly charge for green energy is based on a fixed number of kWh and will be the same amount every month. (R)

OR

Customers may purchase green energy that is equal to 100% of their total monthly energy usage at a rate of \$0.006 per kWh. Under this option the monthly charge for green energy will vary based on energy usage. (R)

The monthly charge in this rider is in addition to all other charges contained in the rate schedule under which the Customer receives service. The monthly charge for the fixed usage option under this rider will be applied to the Customer's billing regardless of actual energy usage. For the 100% option, the minimum monthly charge under this schedule will be equal to the rate times the Customer's monthly energy usage.

ENROLLMENT:

To participate in this program Customers are required to complete the Company's enrollment process, including entering into a service agreement under this Schedule. Initiation of service under this rider will occur following acceptance and processing of the enrollment request and service agreement by the Company. The Company may remove Customers from the rider or refuse to enroll Customers who have not paid the green power portion of their bill.

TERMINATION BY CUSTOMER:

Following the term specified in the service agreement a Customer may choose to renew service for an additional period at the same or different usage levels or if service is not renewed, service will continue on a month to month basis at the monthly levels specified in the existing service agreement until the Customer gives the Company a minimum of sixty (60) day notice of termination. Customers who close their account prior to the end of the term of the service agreement will be subject to the Annual Minimum Charge unless the Company is able to sell the Credits to other customers.

MINIMUM CHARGE:

Where the Customer has chosen the fixed amount option the Minimum Charge over the term of the service agreement will be equal to the difference between the kWh of green energy billed and the kWh of green energy specified in the service agreement over the term of the service agreement multiplied by the lesser of \$0.006 per kWh or the Company's actual cost per kWh.

Where the Customer has chosen the 100% green energy option, the Minimum Charge over the term of the service agreement will be equal to ninety percent (90%) of the projected energy usage (as reflected in the service agreement) less the Customer's actual energy usage multiplied by the lesser of \$0.006 per kWh or the Company's actual cost per kWh.

SPECIAL CONDITIONS OF SERVICE:

1. The Company may limit Customer participation in this rider to balance Customer demand with available credits acquired from qualified alternative energy resources by the Company.
2. The Company shall forecast and plan purchases of green power credits to meet projected quantities purchased on an annual basis.
3. The Company makes no guarantee of any kind that this program will result in the development of any amount of alternative energy resources.
