**Project Overview:** Puget Sound Energy (PSE) is planning a new 115 kilovolt (kV) transmission line to provide additional system capacity and improve system reliability to meet customers' current and future energy needs in Redmond and Kirkland. The new line is anticipated to be approximately 4 miles in length running from the Sammamish substation in Redmond to or near the Juanita substation in Kirkland.

### Meeting Objectives:

- Stakeholder Advisory Group (SAG) to finalize decision criteria for selection of preferred route recommendation.
- SAG to conduct a multi-objective decision analysis (MODA) on the three route alternatives east of I-405 under consideration and select a preferred route for recommendation to the community and to PSE.
- SAG to conduct a multi-objective decision analysis on the two route alternative end point segments (west of I-405) and select a preferred route segment to be combined with the preferred route alternative.

## **Meeting Process:**

- Public comment to SAG welcomed at 6:20 p.m. Commenters must sign up to give comments. The allotted time per comment will be dependent on the number of commenters requesting to speak to the SAG. The SAG and PSE staff will be listening intently and not responding to questions.
