

# Windows rebates form

## Required documentation

- Paid installation invoice<sup>1</sup> or purchase receipt that includes
  - Total number and cost of all windows and patio doors installed.
  - Measurement and type of each window and patio door installed.
- Proof of U-factor rating
  - Packing slip listing the U-factor for each individual window or patio door **or**
  - National Fenestration Rating Council (NFRC) stickers with U-factor for each individual window or patio door.

## General qualifications

Review the general customer qualifications and rebate requirements listed below.

- Must be a current PSE residential customer using PSE electricity or PSE natural gas as your primary home heat source.
- If home has a heat pump (ducted or ductless) serving the majority of the main living area, that is considered primary and you must have PSE electric service. This includes dual fuel hybrid systems (heat pump with natural gas furnace).
- Rebate application must be submitted within 60 days of installation.
- Applies to existing site-built single-family homes<sup>2</sup> and manufactured/mobile homes<sup>3</sup>. Single-family new construction, multifamily (five or more attached units or part of a campus<sup>4</sup>) and commercial accounts are not eligible.
- Rebates only available on new, qualifying products.
- Cannot be combined with any other rebates except where noted.
- Installation must comply with all federal, state and local code requirements.
- Products that are replaced under warranty will not be eligible for second rebate.
- Each qualified single-family residence is limited to 15 windows rebates over the lifetime of the property. Efficiency Boost and Manufactured Home rebates are limited to 10 total windows/patio doors at the higher rebate amount.
- Windows must be installed within a conditioned living space at the time of installation. Garages, unconditioned basements, etc., are not eligible.
- Rebates do not apply if required by building code. This includes, but is not limited to: remodels, renovations, and additions.
- Rebate cannot exceed the purchase price of any rebated product.

<sup>1</sup> Packing slips, contracts, scopes of work, and purchase orders do not qualify as an installation invoice or purchase receipt. An example of a paid installation invoice and NFRC sticker is provided at [PSE.com/Windows](https://pse.com/Windows).

<sup>2</sup> A site-built single-family home is defined as a home built primarily at the location where the home is inhabited; standalone homes, attached housing with four units or less, and modular homes fall under this classification.

<sup>3</sup> A manufactured or mobile home is a factory-built dwelling that includes: (a) plumbing, heating, air conditioning, and electrical systems, normally contained within the belly of the structure and within a rodent barrier; (b) is built on a permanent chassis; (c) can be transported in one or more sections; and (d) may, or may not be permanently affixed to a concrete foundation.

<sup>4</sup> A campus is defined as a multifamily site with multiple buildings, including one- to four-plexes, located within the contiguous parcel, with a single ownership/management entity. Manufactured Home communities are excluded from this multifamily campus classification.

## Qualifying Windows and Patio Doors

- Eligibility is based on the glass and frame of the unit being replaced and the U-factor of the new unit.
- U-factor measures how well a product can keep hot or cold air inside of a room. A lower U-factor means higher efficiency and greater potential for energy savings. For more information, visit <https://efficientwindows.org/window-ratings>.
- Single-pane units have one sheet of glass. Double-pane units have two sheets of glass with air or gas between them.
- The unit being replaced must have metal- or wood-framing holding the glass. Old units with vinyl or plastic framing are not eligible.
- Two or more units in one contiguous opening with no dividing column are counted as one single unit. This includes sliding patio doors.
