

Windows rebates

General qualifications

- Must be a current PSE residential customer.
- Rebate application must be submitted within 30 days of installation.
- You must use PSE electricity or PSE natural gas as the primary source of your home heating.
- Applies to existing single-family properties only. Single-family new construction, multi-family (five or more attached units) and commercial accounts are not eligible. Manufactured home customers should use the Manufactured Home rebate application.
- Rebates only available on new, qualifying equipment.
- Cannot be combined with any other rebates except where noted.
- Must install to comply with all federal, state and local code requirements.
- Products that are replaced under warranty will not be eligible for second rebate.
- Each qualified single-family residence is limited to the lifetime maximum rebate payout.
- Rebate cannot exceed the pre-tax purchase price of any rebated product.

Rebate requirements

- You must have existing single-pane (wood or metal framed) windows or patio doors to qualify for the \$50 incentive for windows with a U-factor of 0.23-0.30. You must have existing single-pane (wood or metal framed) or double-pane (metal framed) windows to qualify for the \$100 incentive for windows with a U-factor of 0.22 or below.
- Existing double-pane windows are only eligible for a rebate if the windows replacing them have a U-factor of 0.22 or below.
- Windows must be installed within the conditioned living areas of the home at the time of installation (garages, unconditioned basements, etc. are not eligible).
- These rebates do not apply to new construction or additions that expand your home's square and/or cubic footage.
- For the \$50 incentive, the installed windows or patio doors must meet the requirements listed below:
 - Windows must have an NFRC rated U-factor between 0.23 and 0.30.
 - Patio doors must have an NFRC rated U-factor of between 0.31 and 0.35 For the \$100 incentive, the installed window or patio doors must meet the requirements listed below:
 - * Prime windows must have an NFRC rated U-factor of 0.22 or lower
 - * Patio doors must have an NFRC rated U-factor of 0.30 or lower.
- Window count is determined by the fenestration (opening) of the replaced windows. Rebate amount is \$50 per window for new windows with a U-factor between 0.23 and 0.30. Rebate amount is \$100 per window for new windows with a U-factor of 0.22 or lower. Customers are eligible for up to 15 rebated windows in total over the lifetime of the property.
- You must attach the required documents as specified on the application including the final installation invoice, **NFRC window stickers or packing slip listing U-Factor**, window measurements.

Attach required documentation - if the below items are not received with your application, rebate processing will be delayed.

A paid installation invoice or purchase receipt* reflecting the cost and amount all of windows installed.

A copy of your packing slip, or copies of your National Fenestration Rating Council (NFRC) stickers, that show the U-factor for each individual window.

The measurement and type of each window or door being upgraded.

* Packing slips, contracts, scopes of work, and purchase orders do not qualify as an installation invoice or purchase receipt.
The same invoice can be submitted for multiple rebates across all available categories, where applicable.

Incentives for home with existing single-pane windows

Windows with U-factor between 0.23 and 0.30

Only homes with existing single-pane windows qualify for the \$50 window incentive.

Windows with U-factor of 0.22 or lower

Homes with existing single pane (wood or metal framed) or double-pane (metal framed) windows qualify for the \$100 window incentive.

Single family homes are defined as:
A) homes built primarily at the location where the home is inhabited;
B) standalone homes, or attached housing with four units or less.
Additionally, for the purpose of this program, modular homes fall under this classification. **Note that most homes that are not manufactured homes will fall under this classification.**
