General qualifications

- You must be a current PSE commercial electric customer.
- You must be replacing existing electric resistance heating.
- Residential metered customers are not eligible
- Your rebate application must be submitted within 60 days of equipment installation

Equipment requirement

- You must install an AHRI Certified ductless heat pump with a minimum HSPF of 8.2 or a minimum HSPF2 of 7.9.
