General qualifications

- Must be a current PSE residential customer.
- Rebate application must be submitted within 30 days of installation.
- You must use PSE electricity or PSE natural gas as the primary source of your home heating
- Applies to factory built manufactured and mobile homes only. See <u>pse.com/mh</u> and definition on pg. 2.
- Rebates only available on new, qualifying equipment.
- Cannot be combined with any other rebates except where noted.
- Must install to comply with all federal, state and local code requirements.
- Products that are replaced under warranty will not be eligible for second rebate.
- Each qualified manufactured home residence is limited to the lifetime maximum rebate payout.
- Rebate cannot exceed the pre-tax purchase price of any rebated product.
- You must use PSE electricity or PSE natural gas as the primary source of your home's space heating.

Rebate requirements

- The installed windows or patio doors must meet the requirements listed below:
- Prime windows must have an NFRC rated U-factor of .30 or lower.
 Patio doors must have an NFRC rated U-factor of .35 or lower.
- Window count is determined by the fenestration (opening) of the replaced windows. Rebate amount is \$200 per window, eligible up to \$2,000 maximum lifetime rebate payout.
- Windows must be installed within the conditioned living areas of the home at the time of installation (garages, unconditioned basements, etc. are not eligible).
- You must attach the required documents as specified on the application including the final installation invoice, NFRC window stickers or packing slip listing U-Factor, window measurements.
- You must have existing single-pane (wood or metal framed) or double-pane (metal framed) windows or patio doors to qualify for this incentive.
- These rebates do not apply to new construction or additions that expand your home's square and/or cubic footage.
