

Manufactured homes rebate application

Get up to \$4,400 cash back from Puget Sound Energy when you purchase an ENERGY STAR® or ENERGY STAR with NEEM+ certified manufactured home.

How to qualify

To be eligible for PSE's manufactured home incentives:

- Home must be located within PSE's service area
- Home must be ENERGY STAR or ENERGY STAR with NEEM+ certified
- A copy of the Northwest Energy-Efficient Manufactured Housing Program™ (NEEM) Certificate of Compliance must be included with application and dated after the Purchase Agreement.*
- Incentive application must be received within 365 days of the NEEM Certificate of Compliance issue date.
- Cannot be combined with other manufactured home PSE rebates

Application instructions

1. Purchase a qualifying manufactured home after January 1, 2024
2. Fill out the rebate application

4. PSE will review rebate application to determine eligibility
