Building Tune-Up Program

A simple way to save energy and money

PSE's Building Tune-Up Program provides incentives for building owners that want to pursue low/no-cost energy efficiency opportunities, but not the full commissioning process. You will work with PSE and a pre-approved Tune-up Specialist to analyze your building's energy consumption, and leverage the building operator's expertise to implement operational and maintenance measures. Your building staff will come away with an improvements checklist, trend data, performance testing, and a final report to maintain the effect of these changes for the long-term.

Is the Building Tune-Up Program right for you?

- Building has 50,000 square feet or more of conditioned space
- Building is at least 75% occupied
- Energy use is higher than expected and/or trending upwards
- Maintenance has been deferred to some extent
- Dedicated building staff desires efficiency training

In order to participate in the Tune-Up program, PSE requires a commitment from the customer that all identified low/no-cost efficiency opportunities be implemented, as long as they are below a certain investment level and payback period (see below).

Building Tune-Up Program

It's easy to improve efficiency and save money with PSE.

How it works:

Tune-Up Phase

- **Pre-approval:** Customer/Contractor submits the PSE Commercial Retrofit Grant Application along with the pre-screening page of the Building Tune-up workbook.
- **Kickoff:** Meet with PSE and your Cx Professional to discuss program commitments, benefits, and targets related to the implementation of this program.
- **Implement:** Cx Professional performs a review of your building's systems and reports both potential capital and O&M opportunities for evaluation and implementation.
- **Payment:** After PSE reviews the tune-up report (including all identified capital and O&M measures) and verification documents, the implementation payment is issued.

- **Performance Period:** A minimum of 10 months is used to verify the energy efficient performance of your building.
- **Track Energy Use:** The customer deploys tools and training necessary to track and maximize energy savings during the performance period (and beyond).
- **Persistence Checks:** Testing procedures provided during the tune-up phase are implemented again to verify measures are still active for optimal building operation.
- **Payment:** At the close of the performance period, PSE will complete an energy analysis and pay the incentive based on realized savings.
