

Electric vehicle home charger rebates

Application instructions

- Must be installed in a property within PSE's electric service area.
- Must be a current residential customer, with electric service.
- Must currently own, lease, or have ordered an EV (electric vehicle), or PHEV (plug-in electric hybrid vehicle).
- Must purchase and install a qualifying EV home charger after 01/01/2024.
 - Visit pse.com/chargers to see a list of qualifying products
- One rebate per qualified single-family residence within a 5-year window.
- Send the following supporting documents to PSE using the email or mail address listed under "Application submission options" in the section to the right.
 - This signed and dated rebate form with all information completed accurately and legibly.
 - A copy, photo, or scan of your receipt of qualifying EV home charger reflecting the retailer, purchase date, manufacturer, model number, price, and proof of payment.
 - If model number is not shown on receipt, include photo of charger showing model number
 - Applications must be postmarked within 60 days of purchase date on your receipt.
