

Income-qualified fuel-switching heat pump rebate

General qualifications

- You must meet specific income qualifications to be eligible for this rebate. Please review the Income Qualifications section below to see if you are eligible based on household size, gross monthly income, and county.
- You must be a current PSE single-family¹ residential natural gas customer. Single-family new construction, multifamily (five or more attached units) and commercial accounts are not eligible.
- Customers with existing electric resistance or hybrid heat pump heating/cooling systems are not eligible.
- Rebate application must be submitted within 30 days of purchase.
- Rebates only available on new, qualifying equipment.
- Equipment that is replaced under warranty will not be eligible for second rebate.
- One rebate per qualified single-family residence.
- Cannot be combined with any other rebates except where noted.
- Must install to comply with all federal, state and local code requirements.
- Rebate cannot exceed the pre-tax purchase price of any rebated product.
- Homes or accessory dwelling units (ADUs) with existing heat pumps are not eligible for a conversion rebate.
- For units that have both HSPF and HSPF2, the HSPF rating will be used to determine eligibility.

Natural gas to ductless heat pump conversion

- Your primary and current heating system must be fueled by natural gas. This includes natural gas forced-air furnaces, boilers, and gas wall heaters.
- Your new ductless system must be AHRI Certified[®] as a mini-split heat pump, use inverter technology, and be a minimum of 3/4 ton in heating mode.
- It must have an HSPF of at least 9.0 or an HSPF2 of at least 8.1.
- At least one indoor head must be installed in the main living area of the home; bedroom only installations do not qualify.
- To qualify for a rebate, ADUs must be occupied full time, must be an additional living area independent of the primary dwelling unit (with no venting from the primary dwelling) and must include a fully functioning kitchen and full bathroom.
- The previous natural gas space heating system must be completely removed and replaced with an electric ductless heat pump system.
 All existing furnace equipment, including the furnace unit itself, must be physically removed from the property.
- Natural gas lines to the heating system must be removed or decommissioned (cut and cap is allowed) after installation of the electric heat pump system.

Natural gas to ducted heat pump conversion

- Your primary and current heating system must be fueled by natural gas. This includes natural gas forced-air furnaces, boilers, and gas wall heaters.
- · Your new ducted heat pump system must be AHRI certified.
- The previous natural gas space heating system must be removed completely and replaced with an electric ducted heat pump system.
 All existing furnace equipment, including the furnace unit itself, must be physically removed from the property.
- Natural gas lines to the heating system are removed or decommissioned (cut and cap is allowed) after installation of the electric heat pump system.

¹ Single-family homes are defined as: A) homes built primarily at the location where the home is inhabited; B) standalone homes, or attached housing with four units or less. Additionally, for the purpose of this program, manufactured homes fall under this classification.

Income qualifications — REQUIRED

Customers eligible for the income-qualified fuel-switching heat pump rebate must have a gross monthly household income equal or less than the maximum income listed in the table below for their county and household size.

Please review the income table below to see if you are eligible based on household size, gross monthly income, and county.

If your income is well below the income limits below, you may be eligible for our comprehensive and no-cost Home Weatherization Assistance program administered through community-based agencies and housing authorities. Please see PSE.com/Home.
