



Commercial windows rebate

Thank you for your commitment to energy efficiency

What you get

For a limited time, receive a rebate of \$30 per square foot when upgrading from single-pane (any frame) and/or \$15 per square foot* when upgrading from double-pane (metal frame) with new windows that have a U-factor of 0.26 or lower.

*Increased rebates are part of a limited-time offer. Rebate amounts will return to \$20 per square foot and \$9 per square foot, respectively, on Dec. 1.

General qualifications

- Must be a PSE commercial electric, natural gas or dual-fuel customer. The fuel source for your heating must be supplied by PSE.
- You must be replacing existing single-pane (any frame) or double-pane (metal frame) windows.
- Applies to existing commercial buildings. Residential, multifamily and new construction are not eligible.
- Your rebate application must be submitted within 60 days of window installation.
- Must be installed by a contractor.

Windows requirement

- New windows with a U-factor of 0.26 or lower.

Invoice must include the measurement and type of each window installed as well as the total cost and total number of windows installed.

Additional requirements
