## Confirm you're qualified

### You have the option to:

- 1) The ENERGY STAR® window incentive does not apply to homes with existing double-pane windows.

### General Qualifications

- Must be a current PSE residential customer for all of the following rebates.
- Rebate application must be submitted within 30 days of installation.
- Qualifying electric products must be installed in PSE's electric service area. Qualifying gas products must be installed in PSE's gas service area.
- Applies to existing single-family properties only. Single-family new construction, multi-family (five or more attached units) and commercial accounts are not eligible.
- Rebates only available on new, qualifying equipment.
- Cannot be combined with any other rebates except where noted.
- Must install to comply with all federal, state and local code requirements.
- Products that are replaced under warranty will not be eligible for second rebate.
- One rebate per qualified single-family residence.
- Rebate cannot exceed the pre-tax purchase price of any rebated product.

### General requirements:

- You must have existing single-pane (wood or metal framed) windows or patio doors to qualify for this incentive.
- The high-efficiency windows or patio doors must be installed to replace the existing single-pane (wood or metal framed) windows or patio doors.
- The installed windows or patio doors must meet the requirements listed below:
  - Prime windows must have an NFRC rated U-factor of .30 or lower.
  - Patio doors must have an NFRC rated U-factor of .35 or lower.
- Window count is determined by the fenestration (opening) of the replaced windows. Rebate amount is \$50 per window, eligible up to \$750 maximum.

- A paid installation invoice or purchase receipt, reflecting the cost and amount all of windows installed.
- For ENERGY STAR double pane windows (.30 or lower): A copy of your packing slip, or copies of your National Fenestration Rating Council (NFRC) stickers, that show the U-factor for each individual window.
- The measurement and type of each window or door being upgraded.
- Note: Packing slips and purchase orders do not qualify as an installation invoice or purchase receipt. The same form can be submitted for multiple rebates across all available categories, where applicable.

### To be eligible for PSE's windows rebate:

- You must be a current PSE residential electric or PSE natural gas customer.
- You must use PSE electricity or PSE natural gas as the primary source of your home heating.
- You must note the primary heating system and fuel type on the application.
- Windows must be installed within the conditioned living areas of the home at the time of submission.
- These rebates are only available on new, qualifying windows.
- Your windows must be installed on or after Jan. 1, 2018.
- These rebates do not apply to new construction, additions that expand your home's square and/or cubic footage, or installations in unheated areas of the home.
- The ENERGY STAR window incentive does not apply to homes with existing double-pane windows.

## Incentives for home with existing single-pane windows

### ENERGY STAR windows with U-factor of .30 or lower

Note: Only homes with existing single-pane windows qualify for the ENERGY STAR window incentive.
