How it works

Weatherization, Windows, Water Heat, and Space Heat programs

1. Review the income guidelines above, and contact an Energy Advisor (EA) to discuss eligibility. The EA will guide you through next steps and can provide referrals to Recommended Energy Professionals (REPs), who are approved to deliver Efficiency Boost rebates.
2. Once you've selected a Recommended Energy Professional, they will ask you to sign an Income Qualification Form to confirm that you meet eligibility requirements prior to installation.
3. After installation, the REP will submit your signed incentive application and Income Qualification Form to PSE and provide you with an instant rebate. Incentives will be paid directly to the REP, who will deduct the incentive amount from your invoice, reducing your out-of-pocket cost. You are responsible for paying the balance of the invoice.

4. Review the income guidelines above. If you meet the income requirements for Efficiency Boost, please visit pse.com/boost to download and complete an Income Qualification form.
5. Submit the Income Qualification form along with your rebate application through PSE's online rebate application portal or to an application email: HomeApplianceRebates@pse.com for clothes washer rebates and ThermostatRebates@pse.com for smart thermostat rebates.
6. If your rebate is approved, a check will be mailed to you or you will receive credit on your account.

Note: Offers available to residential customers with PSE electricity or PSE natural gas as the primary source of home and/or water heating. Home must be permitted and built before 1990 to be eligible for insulation, whole house air sealing, and prescriptive duct sealing and insulation rebates. Duct sealing only applies to homes permitted and built before 2001; cannot be combined with other duct measures. Electric hybrid heat pump water heaters may also be eligible for additional retail or midstream incentives. Please visit

pse.com/instant for more information. Upgrades must be installed by an independent PSE Recommended Energy Professional (REP) pre-approved to provide Efficiency Boost rebates. Customer must meet income guidelines and be prequalified by PSE for Efficiency Boost rebates. Equipment must be installed between 1/1/2022 and 12/31/2022 to qualify.
